

Vestry Meeting (Via Zoom) Minutes (amended) August 11, 2020 6:30 PM

Executive Session:

The Vestry went into Executive Session at 6:34 pm. The session ended at 7:05 pm.

Decision

Wee Love Lease: Regarding excluding COVID coverage, Larry Hitt answered, "I am pleased that all of the suggested changes to the lease were approved except for the insurance reference to COVID coverage. I understand that the insurance market is unlikely to offer this coverage. I think it is OK to proceed with the lease with that provision deleted. Although I don't believe any attorney can say that indemnification provisions, releases and waivers are ironclad protections, I still think they are valuable and would recommend that it be made clear to the tenant and its staff, employees, directors and parents that a release form will be necessary." We have a responsibility to notify people if there is a known danger. There is a level of risk if we offer a lease to Wee Love. Lisa spoke with Jr. Warden at Grace & St. Stephens about their preschool. It closed in the spring, and did a special one-month term lease this summer. Now, G&SS is working on a 12-month lease; they are willing to take the risk to reopen. Jan moved that the Lease is offered to Wee Love. Paul seconded. The motion failed.

Discussion: Gut feeling is go ahead; wait until January. Part of me wants to go ahead; on the fence. This isn't a financial advantage, and yet it's a risk for us. After reviewing the lease, the protocols, my feeling is to offer the lease. The kids need to get back to school; if there is a COVID case, the school will close. We have a responsibility to these people. Weld County has done poorly with cases when compared to other counties. The legal opinion was helpful. Concerned that COVID testing in Weld County is terrible; large number of people not wearing masks. If there was no COVID, we'd already have a lease; a tremendous amount of time has been spent concerning the lease. The risk of liability is very low; however if there is liability the financial loss could be enormous. Our hearts go out to Wee Love; we want to go back to normal. Too many people don't show symptoms. Our first responsibility is to Trinity.
