



**Vestry Meeting (Via Zoom)
May 26, 2020
Minutes**

Attendance: All present.

Business

Minutes May 12, 2020: The May 12 minutes stand as presented.

Financials: April deficit of \$11,011. Total revenue is \$13,774 under budget. Total expenses through April are \$195,905. Net operating loss for the year of \$7,548. We are thankful to have received the PPP grant; this must be spent by early June.

Additions to the Agenda: Julie said Barbara Maxfield called about restarting the food boxes.

Decision

Water Lease: Trinity owns one share of Greeley-Loveland Irrigation Company. We have historically rented this to Glenn Gregory and six other homeowners in Westridge Subdivision. The rental amount is \$300. Last year we researched the value of the share. Glenn has submitted another letter for this year. The one share entitles us to eight or nine days of water – 2 acre feet of water per day. The Irrigation Company rents a share for \$35/day. Trinity will pay \$353.75 to the Irrigation Company. The Finance Committee recommends that we charge \$400 for the rental of this one share. Julie moved that we charge the Westridge homeowners \$400 this year. Jan seconded. Motion passed.

Discussion

Pentecost (Church Birthday Party): May 31 is Pentecost. Lisa, Karoline and Meg have put together a bag containing a red pinwheel, directions to make a Tongue of Flames headdress, a sweet treat of cookies. Pick these up in the parking lot on May 30 from 10-11 and 1-2.

Wee Love Lease: Kim and Chris have been working with Jeff Bedingfield. There is no written lease with Wee Love. Jeff is in the process of drafting a lease. There will be items that are new; insurance will be required. Trinity will also be listed as a named insured on Wee Love's policy.

Compete to Beat Hunger Events (Food Bank): There were many Trinity members at the kickoff. This year the Food Bank is requesting money instead of food because of possible contamination issues.

Diocesan Guidelines/Workbook for Reopening the building: There is much care, thought and work as we evaluate when we can open our building. The issue is very complex; liability, health, safety, disinfecting. Chris recommended that we carefully review the "Guide for Reflection and Planning Transition from Season I to Season II." This document will be discussed in future Vestry meetings beginning in June.
